This form does not need to be completed where the property is being transferred to a surviving joint tenant.

This form should be completed by:

- the person who will own the DSH home; or
- the person with qualifying service if the property is being transferred to joint owners.

Under the DSH Act, the subsidy on a DSH loan cannot continue if the property is transferred to an ineligible person.

Please note: If you are a widow/widower or surviving partner of an eligible person, please disregard the reference to spouse or defacto partner throughout this form.

If you were the widow/widower/surviving partner of an eligible person and have legally remarried since his/her death, you do not qualify for assistance through this application. If you have your own qualifying service, it is suggested that you approach DSH as you may be entitled to another form of assistance.

The information contained in this form will be used to assess your entitlement to a DSH subsidy and for statistical purposes. Only information relevant to your DSH assistance will be disclosed to Westpac Banking Corporation.
