Members **NOTED** the submission submitted by Australian Peacekeeper and Peacemaker Veterans' Association (APPVA) concerning the restrictive nature of the Heart Health Program and whether the program can be extended to include access to all veterans.

Members **NOTED** the eligibility criteria for the Heart Health Program applies specifically to individuals with war-like service or certain pension entitlements.

Members were **INFORMED** that eligibility has been expanded over the past 20 years to include a broader commitment to improve preventative health care for the veteran community.

Members **PARTICIPATED** in a MENTI survey to gather input on how significant anniversaries for more recent wars and conflicts should be commemorated in the coming years.

Agenda Item 9 Update on Grants

Members **NOTED** the update regarding the annual and terminating grants administered by the Grants and Hubs Branch.

Members **DISCUSSED** grant operating guidelines and the how assessments are made in administering grants.
