

Claim for \$25,000 Ex-gratia Payment by a Civilian interned by Japan during World War II

On 22 May 2001 the Government announced a \$25,000 payment in recognition of the unique hardships suffered by former Prisoners of War and civilians who were interned by the Japanese.

WI	no is eligible?	 This form relates to a person who: was alive on 1 January 2001, and was a civilian, who was interned or detained by the Japanese between 7 December 1941 and 29 October 1945, and was, immediately before their internment, domiciled in Australia.
De	ceased civilians	If an eligible civilian has died on or since 1 January 2001 this form should be completed by the executor of their estate. If an eligible civilian died before 1 January 2001, their widow or widower who was alive on 1 January 2001 is eligible for a payment. The civilian's death does not have to be due to internment. The remarriage of a widow or widower does not affect eligibility for a payment. However, a person who was divorced from an eligible civilian is not their widow or widower and cannot claim.
