Department of Veterans' Affairs Card Images
Conditions of Use

These Conditions of Use apply to any Non-Commonwealth Government Agency requesting the right to reproduce the Department of Veterans' Affairs Card images (i.e. the Gold, White and Orange Cards, the Pensioner Concession Card, the NSW Transport Concession Card and the Commonwealth Seniors Health Card (CSHC).

On accepting the supply of the images you agree to:

The party to whom this licence has been granted agrees to comply with the following conditions in relation to the card image(s):

- All rights not specifically granted in this Licence are reserved to the Licensor. Unless otherwise specified, this Licence does not include any additional or yet to be devised image.
- This Licence is limited to the Specified Purpose stated in the Licence.
- The Licensee must not edit, enhance, distort or alter the Image(s) in any way.
- The Licensee must not make any copy of the Image(s), in whole or in part, except for use in connection with the Specified Purpose.
- Permission for any additional use of the Image(s) will require a separate licence to be sought from the Department of Veterans' Affairs.
- The Licensee will not lend, give or allow use of the Image(s) to or by any person, organisation or company or other than the Licensee.
- The Licensee will not use the Image(s) for a purpose that may reasonably be perceived as derogatory to or critical of the Licensor or any officer, agent, employee, affiliate, parent or subsidiary of the Licensor.
- The Licensee will indemnify the Licensor and all of its officers, agents, employees, representatives and associates and save and hold each of them harmless against all claims, damages, liabilities, costs and expenses, including legal expenses, arising out of any breach of this Licence by the Licensee.
- The Licensor may terminate this Licence immediately by written notice to the Licensee if the Licensee commits a breach of any term of this Licence.
- This Licence may only be varied in writing and by written agreement between the parties to the Licence.
- This Licence is personal to the specified Licensee and must not be assigned without the Licensor's prior written consent
- The Licensee agrees to store the Image(s) securely in a manner where unauthorised access is prevented.
- The person signing on behalf of the Licensee warrants that they are an authorised representative of the Licensee and have full authority to sign on its behalf.
- The Image(s) will be destroyed in a secure manner upon finalisation of the approved use of the images.
- This Licence will be governed by and construed in accordance with the laws of the Commonwealth of Australia, and each party irrevocably and unconditionally submits to the non-exclusive jurisdiction of the courts of the Commonwealth of Australia.
